To Whom It May Concern:


Enclosed please find our report for the pre-primary campaign. With this report you will find some changes. As in the past, we have reported the funds raised within the CULAC/PAC joint fundraising account. This report will contain all receipts and expenditures from January 1, 2006 to May 27, 2006 within our State PAC. Therefore, our balance indicated for December 31, 2005 is not \$27,917.60, but should be \$299.83.

Due to the FCC rules, contributions must be deposited within 30 days of the contributor giving the contributions. Therefore, the \$27,917.60 amount could not be split between the CULAC and the state PAC as the funds were given beyond the 30 days. So on January 5, 2006 the funds were all disbursed into the state PAC account.


