As I mentioned to you when I called you last week, it had come to my attention that I may have made some bookkeeping errors in regard to three political committees that I had responsibility for either currently or during calendar year 2003.

Please find enclosed amended reports for the Wanalain Committee and the Capitol Committee. After review of bank records, it appears that I had attributed contributions made to the Wanalain and Capitol Committees by Lois Quam directly to the South Dakota Democratic State House Fund.

I take full responsibility for the errors as I had, at the time, oversight of all three committees prior to my stepping down as Executive Director of the South Dakota Democratic Party. The enclosed amended reports reflect contributions by Ms. Quam to the Wanalain Committee of \$30,000 and to the Capitol Committee in the amount of \$25,000.

I have informed the South Dakota Democratic State House Fund of the error so they may amend their 2003 report accordingly.
