

Dear Secretary Nelson:

As your office is aware, South Dakotans for 1215 / VoteYesForLife.com (the Committee) is a ballot question committee and was formally organized on May 11, 2006. The Committee is a non-partisan coalition formed to defend and support the Women's Health and Human Life Protection Act, which was enacted as HB1215 by a bi-partisan majority of the members of the South Dakota Legislature.

On June 19, 2006, your office announced that proponents of abortion on demand had filed a sufficient number of signatures with your office to refer the Women's Health and Human Life Protection Act to a public vote. Accordingly, the Committee filed with your office a detailed statement of expenditures and contributions that the Committee had made or received as of June 30, 2006.

In the short period of time since the Committee was formally organized, donations in excess of \$100 have been numerous and the donations are reported on an Itemized Contribution Attachment to Schedule A of the June 30, 2006 report. Because almost every donation that the Committee had received prior to June 30, 2006 was not solicited by the Committee, employment information was not provided by many of the early donors. The information reported on the Attachment to Schedule A is the information known to me as the Treasurer of the Committee as of June 30, 2006.

The Committee has mailed a letter to each of the donors whose employer is marked as "Requested (not provided with donation)" on the Attachment to Schedule A. The Committee will file a supplemental Schedule A with your office on or before July 31, 2006.
