

Based on direction from the South Dakota Secretary of State's office, a Statement of Organization for "SDCRT 2008 Ballot Question Committee" was filed in anticipation of opposition to an initiated measure to increase alcohol taxes in the event the organization might, following certification of an actual ballot question, become a ballot question committee pursuant to South Dakota law. As no such initiated measure qualified for the 2008 general election ballot, the "SDCRT 2008 Ballot Question Committee" did not become a ballot question committee as defined in South Dakota law and so is terminated.
