State law requires statewide and legislative candidate committees, political action committees (PAC) and ballot question committees to register with the Secretary of State. Candidate committees must register within fifteen days after becoming a candidate. Candidate committees that have not already filed a statement of organization, PACs and ballot question committees must register not later than fifteen days after the date upon which the committee made contributions, received contributions or paid expenses in excess of five hundred dollars unless such activity falls within thirty days of any statewide election in which case the statement of organization shall be filed within forty-eight hours.





Statement of Purpose and Goals:

Section 1. The objectives and purposes of PAC shall be in conformity with those set forth in the Uniform Local Union Constitution of the Laborers' International Union of North America and the actions, policies, rulings, orders and decisions of the hereinafter described Administrative or Executive Committees.

Section 2. The objectives shall include: informing the member of Local 620 of South Dakota as to the need for the exercise of their right to vote; the passage of favorable legislation; the repeal or revision of unfavorable legislation; a program of education about such laws, their supporters and opponents; to support candidates for office who demonstrate concern for the working man and for the aims and objectives of Local 620 and the entire trade union movement; to cooperate with, assist and support candidates and organizations approved by the Administrative or Executive Committees, and other legitimate activities calculated to accomplish these objectives.

Section 3. This activity shall be financed by contributions from persons who subscribe to the objectives of this Committee.

Section 4. This organization shall be confined to the State of South Dakota in its operations.
