



I am writing this letter per our phone conversation on October 24, 2002 regarding the beginning balance on our pre-general campaign report for IFAPAC-SD who is affiliated with NAIFA-SD.

Your records showed that the ending balance was \$42,439.11 as of the last report dated May 26, 2002. I took over management of the IFAPAC-SD group in 2001.
