

Upon completing the pre-general election report we had a large negative balance that did not reflect our actual financial status. We review our previous reports to the state and found several mistakes.

Income late in 2008 from a RESIST grant was mistakenly deposited in to PAC account (see previous letter on file). The funds were returned to RESIST but mistakenly were noted as expense in the 2009 report, but not as income. When the \$2,500 is added to the carry-over balance for the May, 2010 report it should be \$3,635.23, not \$1,118.23. A mistake was found in the expense on the May, 2010 report and with the different carry-over the end figure should be \$2,712.60 to begin the October, 2010 report.


