In accordance with Section 2.1, prequalification on state highway construction contracts is required unless the amount being bid is less than \$250,000.

To request prequalification for specialty work for this project, a prospective bidder must submit a Contractor's prequalification statement on a form approved by the Department ([Contractor Prequalification Statement Form](#)), in accordance with Section 2.1 except the application must be received by the Department's classification and rating committee at least 7 calendar days before the opening of the prospective bidder's bid, unless a shorter time frame is approved by the committee. The application must include the prospective bidder's qualification requirements as required below.

Slope Mesh

The Contractor will provide documentation of at least three (3) projects completed during the past three (3) years that have involved similar rockfall fence systems. All work requiring rope access will be in accordance with the Code of Federal Regulations 1926.501 B15 and/or other prevailing State or Federal requirements.

Slope Mesh Anchors

The Contractor will provide documentation of at least three (3) projects completed during the past three (3) years that have involved similar anchor systems. Drilling operators will have a minimum of three years of experience installing similar systems and will be on site for 100% of the time during drilling and grouting aspects of the work being performed.

Rockfall Fence

The Contractor will provide documentation of at least three (3) projects completed during the past three (3) years that have involved similar rockfall fence systems.

Soil Nail and Ground Anchors

The Contractor will provide documentation of at least three (3) projects completed during the past three (3) years that have involved similar soil nail and ground anchor systems. Drilling operators will have a minimum of three years of experience installing similar systems and will be on site for 100% of the time during drilling and grouting aspects of the work being performed.

For this project, Slope Mesh, Slope Mesh Anchors, Rockfall Fence, Soil Nails, and Ground Anchors are considered specialty work but are not considered a “specialty item” as specified in Section 8.1 of the specifications and all requirements of Section 8.1 will apply.
