The notes regarding removal of High Tension Cable Guardrail were revised. The revised notes explain that anchors and sleeves need not be removed and will remain in place.

The notes regarding Object Markers were revised to denote an approx. 200' spacing.

Discard Sheet 9 of 15 and replace it with the enclosed Revised Sheet 9 of 15.

The following gradation information for Select Granular Backfill was added to the note:

Select Granular Backfill will conform to the following gradation requirements:

Passing a 2 Inch Sieve	100%
Passing a 1½ Inch Sieve	95%
Passing a 1 Inch Sieve	15-30%
Passing a 3/4 Inch Sieve	5-10%
Passing a 3/8 Inch Sieve	0-5%
Passing a No. 4 Sieve	0-5%

All other requirements of the specifications for Select Granular Backfill will apply.

The note regarding Remove High Tension 3 Cable Guardrail was revised. The revised note explains in more detail that Anchors and sleeves need not be removed and will remain in place.
