THE FOLLOWING UTILITY COMPANIES ARE INVOLVED ON

PROJECT: 445-452 PCN I24H Pennington County

The contractor shall contact the following utilities in a sufficient amount of time prior to starting work. The companies will identify their facilities and it is the responsibility of the contractor and the company to coordinate their work to avoid damage to existing facilities and to allow for relocation of facilities as may be required for grading work:

The following utilities were determined to be involved and were notified by certified mail that the work done on this project is being done within the existing public right-of-way and that if their facility is located within the existing public right-of-way, any adjustment of their facility would have to be accomplished at no cost to the State, within 90 days from receipt of the notice, unless other arrangements are made with the Area Engineer.

Knology has a fiber telecommunication line in the public right-of-way running north and south on the Westside of Deadwood Avenue which crosses Cement Plant Road near approximate stations 3+10 and 3+15. The fiber is buried three to four feet in the intersection and should not require adjustment.

Qwest has copper telecommunication line along Deadwood Avenue crossing Cement Plant Road. Qwest also has a copper line running parallel with Cement Plant Road on the north side. Qwest has a pedestal in the public right-of-way at approximate station 2+30-L which will be relocated at no cost to the state.

Montana Dakota Utilities has an underground 2 inch steel intermediate natural gas line crossing Cement Plant Road near approximate station 2+25. This line should not require adjustment, however, if grade changes are made to the design the company has requested they be contacted.

Williston Basin Interstate Pipeline has an underground 6 inch steel high pressure natural gas transmission pipeline located to on the south side of Cement Plant Road lying parallel with Cement Plant Road. This line should not require adjustment as the proposed highway construction is on the north side of Cement Plant Road only.
